

# General Terms and Conditions

## 1. Introductory provisions

1.1 These General Terms and Conditions (hereinafter referred to as "GTC") govern the rights and obligations between the operator of the website [www.nightoutprague.cz](http://www.nightoutprague.cz) (hereinafter referred to as 'Operator') and the users (hereinafter referred to as "Customer") who make a reservation at the Goldfingers Club through this website.

## 2. Subject of service

2.1 Through the website it is possible to book a table at the Goldfingers Club.

2.2 The reservation is considered binding after payment, unless otherwise stated.

2.3 The reservation is only for a specific date, time and place as selected by the Customer in the reservation form.

## 3. Prices and payment terms

3.1 The price for a booking is shown for each table on the Website and is final.

3.2 Payment can be made online using a payment gateway, and or other payment methods.

3.3 Once payment has been made, the Customer will receive a confirmation of the booking by email to the email address provided at the time of booking.

## 4. Cancellation and cancellation policy

4.1 The customer can cancel the reservation free of charge, no later than 24 hours before the booked date.

4.2 For cancellations 24 hours or less from the booked date, the cancellation fee is 100%.

4.3 The Customer may reschedule the reservation to any other date free of charge, in consultation with the reservations department.

## 5. Rights and obligations of the Customer

5.1 The Customer is obliged to provide true and complete information when making a reservation.

5.2 The Customer agrees to abide by the Club's Visitor Regulations and to respect the rules of conduct on the Club premises.

5.3 Entry to the Club may be refused to persons under the influence of alcohol, drugs or other intoxicants without compensation.

## **6. Protection of personal data**

6.1 The Operator processes the personal data of Customers in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council (GDPR) and other applicable data protection legislation.

6.2 Personal data is processed only to the extent necessary to secure the booking, communicate with the Customer and fulfil the Operator's legal obligations.

6.3 Personal data will not be passed on to third parties without the express consent of the Customer, except as provided by law or necessary for the technical provision of the service (e.g. payment service providers).

6.4 The Customer has the right to access, rectification, erasure, restriction of processing, portability and may object to processing or lodge a complaint with the Data Protection Authority at any time.

## **7. Claims**

7.1 Complaints regarding reservations can be made in writing to the Operator's e-mail within 5 days of the occurrence of the reason for the complaint.

7.2 The Operator undertakes to settle the complaint promptly, but within 14 days at the latest.

## **8. Final provisions**

8.1 These GTC are valid and effective from 1 May 2025.

8.2 The Operator reserves the right to amend these GTC at any time; the amendments come into force on the date of publication on the website.

8.3 These GTC are governed by the law of the Czech Republic.
